Terms & Conditions

1. Eligibility:

- 1.1 The Jade Homes Sdn Bhd Tesla Giveaway Lucky Draw (hereinafter referred to as the "Lucky Draw") is open to individuals who are 18 years of age and above who fulfil the terms and conditions stipulated herein.

2. Campaign Period:

- 11.2 The Participant acknowledges that Jade Homes Sdn Bhd have relied on the Participant's representations and warranties as set out in Clause 11.1 and such representations and warranties are valid and effective for the duration of the Lucky Draw.

 - (b) give any product endorsement, any interviews or be involved in any articles or reports in respect of the Lucky Draw with any third party.

14. TERMINATION, DISCONTINUATION AND SUSPENSION
